Sub:- Tender notice for disposal of non-issuable (damaged) foodgrains lying at various depots of Kerala Region – Reg.

Sealed tenders are invited from the parties registered with FCI for purchase of non-issuable (damaged) foodgrains lying at various depots in Kerala Region on “As is where is basis”. The statement showing districtwise / depotwise / commoditywise / categorywise availability of non-issuable(damaged) foodgrains is enclosed herewith for information.

The reserve price of damaged foodgrains has been determined on the basis of prevailing Central Issue Price (CIP) of Sound grains for APL families.

The formula rate of sale of damaged food grains is as under

1.Feed.I :- 75% of CIP for APL families (Damaged Foodgrains suitable for **Animal Feed**).

2.Feed.II:- 60% of CIP for APL families (Damaged foodgrains suitable for **Cattle Feed**).

3.Feed.III:- 45% of CIP for APL families (Damaged stocks suitable for **Poultry Feed**).

4.Ind.Use:- 25% of CIP for APL families (Damaged foodgrains suitable for **Industrial use**).

5.Manure:- 10% of CIP for API families (Damaged stocks suitable for **Manure purpose**).

6.Dumping:- Present CIP for AL families is as under.

Wheat Rs.610/- Per Qtl.

Rice Rs.830/- Per Qtl

If you are interested in purchase of above stocks, you may contact this office for tender forms and other details which will be supplied at the rate of Rs.565 /- (Rupees Five hundred Sixty-five only) per Tender Form if received in person (inclusive of tax) and Rs.626/- (Six hundred and twentysix only) if delivered by post. Both are inclusive of tax and both remittances are non refundable. Cost of Tender Forms may be remitted in the form of Pay-order/Account Payee DD obtained from any Scheduled Bank payable at Trivandrum in favour of General Manager(Kerala), FCI, RO,Trivandrum. Further, Tender Forms also can be down loaded from the Website No. www.fci.sz.tn.nic.in and the cost of Tender Form in DD or cash shall be remitted at the time of submission of Tender offer. Tender Form will not be supplied at free of cost.

The tender form duly filled shall be accompanied by valid trade/Manufacturing license, latest renewal of registration, latest year income tax clearance certificate and EMD equivalent to 10%, cost of the value of stocks for which offer has been made. The EMD shall be paid on any schedule bank in favour of GM(Kerala), FCI,RO, Trivandrum. Duly filled tender forms will be accepted upto 14.00 hrs on 16.02.2010 and will be opened on at 14.30 hrs on the same day in the RO,Trivandrum.

Conditional Tenders will not be accepted

The Tenderers can see the lots at the concerned depots on all working days during office hours.

The tenderers should produce a utilization certificate after taking delivery of the lots.

This office will not be held responsible for delayed receipt of tender form by post and the tenderers may ensure that the forms are received by them in time and the duly filled forms submitted in time.

It is also intimated that in the even of being successful and on issue of acceptance letter you have to make payment of entire amount of cost of foodgrains within a period of 7 days. The quantity allotted should also be lifted within a period of 30 days from the date of issue of RO as per the terms and conditions stipulated in Tender No further extension shall be granted thereafter.

The FCI reserves the right to withdraw/include from the sale of any lot/stock prior to acceptance of any rate of such lots and also accept or reject any or all lots from the tender without assigning any reason.

In respect of matters concerned with this tender, decision of GM will be final and binding on all participating tenderers. All rights including addition or deletion of any figures/quantity is reserved by FCI.
